- 1 CHMN STAFFORD: Let's go on the record.
- Now is the time set for the continuation of the
- 3 hearing on line siting matter 218.
- With me are Members French, Members Mercer,
- 5 Members Drago, Member Hamway, Member Little.
- 6 MEMBER PALMER: And me.
- 7 CHMN STAFFORD: I'm drawing a blank. Member
- 8 Palmer.
- 9 MEMBER HAMWAY: It's a long name.
- 10 CHMN STAFFORD: With us online is Member
- 11 Gentles.
- 12 Are we ready to resume the hearing?
- 13 I believe that the parties were ready to provide
- 14 their closing arguments; is that correct, Ms. Grabel?
- 15 MS. GRABEL: Thank you, Mr. Chairman. Yes.
- 16 Perhaps before doing so we do have our Exhibit 17 that
- 17 has been uploaded to your tablets, and we also have a
- 18 hard copy available. And just to refresh your
- 19 recollection, this is the letter to the company from
- 20 Kinder Morgan regarding colocation of the gas pipelines.
- 21 CHMN STAFFORD: Would you like to move for
- 22 admission for that into evidence?
- 23 MS. GRABEL: I would like to move for admission.
- 24 I want you to take a look at it real quick to make sure
- 25 that it is what I say it is.

- 1 CHMN STAFFORD: Okay.
- 2 MS. GRABEL: But I would like to move to admit
- 3 it if possible.
- 4 CHMN STAFFORD: All right. UNSE-17 is admitted.
- 5 (Exhibit UNSE-17 was admitted.)
- 6 MS. GRABEL: Thank you very much.
- 7 Shall I --
- 8 CHMN STAFFORD: Please proceed.
- 9 MS. GRABEL: Thank you very much.
- 10 CHMN STAFFORD: Thank you.
- 11 MS. GRABEL: So then I would like to thank the
- 12 Committee for their time, their travel and their diligent
- 13 consideration of the project before you.
- 14 I feel privileged to represent TEP and UNSE in
- 15 line siting proceedings. I think that this hearing has
- 16 demonstrated that this is a company that takes its
- 17 obligation to serve customers seriously, but it also
- 18 takes seriously how meeting that obligation will impact
- 19 stakeholders.
- 20 Mr. Bryner just came up and told me this morning
- 21 that he spent his morning run running the trails of
- 22 Circle Z to better understand how the transmission line
- 23 would impact the horse riding routes. And I really think
- 24 that demonstrates how this company goes above and beyond
- 25 to understand the impact of their projects on

- 1 stakeholders.
- 2 The proposed route was the result of years of
- 3 detailed analysis, ground truthing -- a word I think we
- 4 all just learned -- public outreach and personal
- 5 engagement with the people affected by the project,
- 6 including many of the residents who made public comment,
- 7 and Mr. Edwards who made a limited appearance in this
- 8 matter.
- 9 The concerns of the Lake Patagonia area
- 10 residents are understandable, but the impact of this line
- 11 to them is likely to be far less onerous than they
- 12 presently anticipate. The proposed route is located a
- 13 half a mile away from the closest residence in the Lake
- 14 Patagonia Estates and a mile away if Route 2B is
- 15 selected. It will be minimally visible at either of
- 16 those distances.
- 17 The line has been designed to blend into the
- 18 environment to the greatest extent possible, nestle
- 19 behind hills to minimize the visual impact to viewers and
- 20 constructed by self-weathering poles colored similarly to
- 21 the desert environment.
- 22 As we saw from the visual simulations, the
- 23 transmission line for the most part will be less visible
- 24 than the existing distribution line that runs through
- 25 this area.

- I think the evidence was also clear that there
- 2 is a true need for this project. As we heard from
- 3 Mr. Risner, South 32nd, which is UNSE's existing
- 4 customer, has spent more than \$2 billion dollars on their
- 5 project and is pre-funding construction of the line.
- 6 This is not a line that is going to nowhere.
- 7 Mr. Risner's testimony was also clear that South 32nd was
- 8 meticulous in calculating the 87-megawatt load increase.
- 9 And Mr. Bryner explained why that need can only be met
- 10 through a 138 kV transmission line.
- 11 The company has done its best to ensure that the
- 12 route chosen has a minimal impact on the environment and
- 13 ecology of the state, and we therefore respectfully
- 14 request that the Committee approve the proposed route and
- 15 authorize the CEC. Thank you.
- 16 CHMN STAFFORD: Mr. Acken.
- 17 MR. ACKEN: Thank you, Chairman. Good morning,
- 18 members of the Committee.
- 19 We really appreciate your consideration of the
- 20 transmission line project, and, again, coming to Nogales
- 21 to do so. I just want to echo some of the comments that
- 22 Ms. Grabel just made.
- We respectfully submit that this record contains
- 24 a clear demonstration of need. As Pat Risner testified,
- 25 South 32nd's current options require more power than the

- 1 distribution line can provide. And the Hermosa project
- 2 will be a model of sustainable development and an
- 3 economic powerhouse for Santa Cruz County.
- In addition, as Mr. Bryner testified, the
- 5 transmission line project will also provide reliability
- 6 benefits to residents in the area.
- 7 I want to specifically echo Ms. Grabel's
- 8 comments about UNSE's efforts. I see a lot of these, and
- 9 you see them all. I think that their efforts in this
- 10 case are really topnotch. The public outreach process
- 11 was robust and thorough.
- 12 The witnesses presented testimony of thoughtful
- 13 and comprehensive assessment of alternatives and their
- 14 rationale for the preferred route that's before you now.
- 15 And so South32 does recommend the preferred
- 16 alignment, which best follows linear features and
- 17 balances competing resource considerations.
- 18 At the end of the day as a result of UNSE's
- 19 efforts, and the siting process, you have before you an
- 20 evidentiary record that clearly shows the preferred route
- 21 is environmentally compatible.
- We thank you for your time and respectfully
- 23 request your support for the CEC.
- 24 Thank you.
- 25 CHMN STAFFORD: Thank you, Mr. Acken.

- 1 Members, any discussion?
- 2 MEMBER FRENCH: Mr. Chairman.
- 3 CHMN STAFFORD: Yes, Member French.
- 4 MEMBER FRENCH: With respect to this new piece
- 5 of evidence that was admitted this morning, the letter
- 6 from the El Paso Natural Gas Company, there are a couple
- 7 of things that I have questions about that may be best
- 8 answered by South32.
- 9 First, in the letter it states that, "EPNG will
- 10 require the project to fund an alternating current
- 11 induction study before construction and also any impacts
- 12 that are identified in this study that they will be at
- 13 the project expense."
- 14 And then also that "UNSE cooperates with
- 15 attaining the study and required mitigations and complies
- 16 with the guidelines that are attached."
- 17 Can you please discuss that?
- 18 CHMN STAFFORD: Mr. Acken, would you like to
- 19 have your witness take the stand again?
- 20 MR. ACKEN: Yes. And maybe he can sit here in
- 21 the interest of expediency so that he and I can both look
- 22 at this. I'm not sure if Mr. Risner has seen this letter
- 23 before, but I will ask him to see whether he has.
- 24 CHMN STAFFORD: And I'll remind Mr. Risner he's
- 25 still under oath. Thank you.

- 1 MR. RISNER: I have not seen the letter before
- 2 but I have just read the paragraph on the study.
- 3 MR. ACKEN: Mr. French, is the question whether
- 4 that is part of South32's commitment to fund construction
- 5 of the project?
- 6 MEMBER FRENCH: Yes.
- 7 MR. RISNER: Yes. If this study is required, we
- 8 would fund it as part of our commitment to the project.
- 9 MEMBER FRENCH: Thank you.
- 10 MEMBER LITTLE: Mr. Chairman.
- 11 CHMN STAFFORD: Yes, Member Little.
- 12 MEMBER LITTLE: Along those lines, does the
- 13 condition that is in the proposed CEC cover these
- 14 requirements do we suppose, or will we need to expand
- 15 that when we get to that point? A legal question.
- 16 CHMN STAFFORD: I think I'll let Ms. Grabel
- 17 answer that question.
- 18 MS. GRABEL: Thank you, Chairman Stafford. I
- 19 honestly do not know the technical difference between
- 20 what EPNG is requiring and what a cathodic protection
- 21 study would be. Perhaps, Mr. Bryner can answer that
- 22 question.
- 23 MR. BRYNER: It's my understanding -- am I okay
- 24 to speak?
- 25 CHMN STAFFORD: Yes, go ahead, Mr. Bryner. I

- 1 will remind you you're under oath still.
- 2 MR. BRYNER: Thank you, Chairman.
- 3 It's my understanding it is identical to the
- 4 requirement that's in the condition.
- 5 MS. GRABEL: Thank you.
- 6 MEMBER LITTLE: Thank you.
- 7 CHMN STAFFORD: Before we pull up the draft CEC
- 8 and start discussing the conditions, I wanted to have
- 9 kind of a general discussion among the members about what
- 10 route we should be considering.
- 11 Should we be -- consider it to be approving the
- 12 recommended route, or does anybody have an interest in
- 13 selecting one of the alternative routes?
- 14 MEMBER HAMWAY: Mr. Chairman.
- 15 CHMN STAFFORD: Yes, Member Hamway.
- 16 MEMBER HAMWAY: I think I might have an interest
- 17 in selecting 2B.
- 18 CHMN STAFFORD: 2B. Well, I would refer the
- 19 Committee to page E7 of the application.
- 20 MEMBER HAMWAY: E7?
- 21 CHMN STAFFORD: Yeah, E7. It's about an inch
- 22 and a half down into the application.
- 23 MEMBER HAMWAY: Right. Okay.
- 24 CHMN STAFFORD: No, not the exhibit list. The
- 25 application itself.

- 1 MEMBER FRENCH: Mr. Chairman, would it be
- 2 possible to have that projected? I don't have my binder
- 3 with me.
- 4 CHMN STAFFORD: Yes, that would be great. Is
- 5 that possible, the A/V team?
- 6 A/V TEAM MEMBER: Mr. Chairman, it is possible.
- 7 Just give us one minute to find that page.
- 8 CHMN STAFFORD: Thank you.
- 9 It would also be helpful to project the map with
- 10 the alternate routes on the opposite screen so we can see
- 11 what we're talking about. Thank you.
- 12 Can everybody see that now?
- On the screen on the left you can see the visual
- 14 impact assessment.
- 15 MEMBER GENTLES: I can't see it.
- 16 CHMN STAFFORD: Oh, Member Gentles.
- 17 MEMBER GENTLES: Yes, Member Gentles. I see a
- 18 document with a grid but not a map.
- 19 CHMN STAFFORD: Do you have your copy of the
- 20 application handy?
- 21 MEMBER GENTLES: Well, I'm trying to find it in
- 22 this binder.
- 23 CHMN STAFFORD: It's under the E tab. It's
- 24 page 7 of Exhibit E to the application.
- 25 MEMBER GENTLES: All right. Thank you. All

- 1 right. Thank you.
- 2 CHMN STAFFORD: All right. Does everybody have
- 3 the pages in front of them? Members?
- 4 MEMBER LITTLE: Yes.
- 5 CHMN STAFFORD: Okay. You can see from Table 10
- 6 the visual impact assessment that Section 2A, 2B, and 1C
- 7 have the lowest visual impact.
- 8 MEMBER LITTLE: The most or the least?
- 9 CHMN STAFFORD: The least. They're ranked.
- 10 They're scored and ranked based on types and number of
- 11 exposure.
- 12 And given the fact that we've had a lot of
- 13 public comment about the visual impacts I thought it was
- 14 worth a discussion about choosing which -- whether the
- 15 preferred or alternate route is more compatible.
- 17 CHMN STAFFORD: Member Hamway.
- 18 MEMBER HAMWAY: Yes. I'm sorry. Does this say
- 19 that 2B has the lowest visual impact assessment?
- 20 CHMN STAFFORD: It has 2B is the lower visual
- 21 impact than 1A.
- 22 MEMBER HAMWAY: Correct. But --
- 23 CHMN STAFFORD: And that 2B has a lower visual
- 24 impact than 1B and that 1C has a lower visual impact than
- 25 2C.

- 1 MEMBER HAMWAY: Okay. I think the major hit on
- 2 2B, if I can remember, was the fact that it was creating
- 3 a new utility corridor; is that correct?
- 4 MS. GRABEL: Yes, ma'am, that's correct.
- 5 MEMBER LITTLE: Okay. Mr. Chairman.
- 6 CHMN STAFFORD: Yes, Member Little.
- 7 MEMBER LITTLE: I think I would be in favor of
- 8 considering both 2A and 2B. And then up in the area in
- 9 the C area sticking with the preferred Route 1C. That
- 10 would be my preference.
- 11 CHMN STAFFORD: Yes. I'm inclined to agree with
- 12 that, Member Little.
- 13 MEMBER HAMWAY: So, Member Little, what are
- 14 you --
- 15 MEMBER LITTLE: The alternative in the A area,
- 16 2A, the alternative in the B area, 2B, and then in the C
- 17 area --
- 18 MEMBER HAMWAY: Yeah, I wouldn't mess with that
- 19 one.
- 20 MEMBER LITTLE: -- preferred one.
- 21 CHMN STAFFORD: Because I understand that those
- 22 would move the line further away from residences.
- 23 MEMBER LITTLE: Right. It was pretty clear to
- 24 me that the residents preferred those alternatives, and I
- 25 think that's important.

- 1 CHMN STAFFORD: And I think everybody agrees on
- 2 1C. I think the big question with 1C is going to be the
- 3 Forest Service. But it passes through the Forest Service
- 4 in two other spots before it gets to 1C anyway. So I
- 5 fail to see how why the Forest Service how -- why the
- 6 Forest Service would prefer the 2C route when it still
- 7 has miles of line through -- it can't avoid the forest.
- 8 It cannot. So to take that little chunk out to run it
- 9 through the neighborhood doesn't seem to make any sense
- 10 to me.
- 11 MEMBER PALMER: I agree.
- 12 CHMN STAFFORD: Do any members have questions
- 13 for the Applicant?
- 14 MEMBER PALMER: I would be interested to know
- 15 their thoughts on the proposal to use 2A and 2B because
- 16 those appear to be --
- 17 CHMN STAFFORD: Ms. Grabel, would your like to
- 18 have Mr. Bryner address that?
- 19 MS. GRABEL: Certainly.
- 20 Mr. Bryner, what would the company's position be
- 21 if the Committee adopted Routes 2A and 2B as opposed to
- 22 preferred alternatives?
- 23 MR. BRYNER: Yes. So as discussed, the primary
- 24 difference between -- or the distinguishing factor of why
- 25 we selected 1A and 1B over 2A and 2B -- those will

- 1 continue to haunt me forever.
- 2 MEMBER HAMWAY: Us too.
- 3 MR. BRYNER: It was really just that existing
- 4 linear infrastructure. That was the reason why the other
- 5 was selected over this.
- 6 Yes, from a visual standpoint, the other -- the
- 7 alternative routes faired better primarily because of the
- 8 distance to the residential areas as opposed to the
- 9 preferred routes.
- 10 The only reason we selected the preferred was a
- 11 result of that trying to collocate with an existing
- 12 corridor.
- 13 As the company, we have no problem with the
- 14 alternative routes. They're viable routes that we can
- 15 build.
- 16 CHMN STAFFORD: And the utility easement you're
- 17 talking about is the natural gas line; correct?
- 18 MR. BRYNER: For 1A it's the natural gas line.
- 19 For 1B it would be the linear infrastructure of the
- 20 highway.
- 21 CHMN STAFFORD: The highway, is that what it
- 22 was?
- MR. BRYNER: Correct.
- 24 CHMN STAFFORD: Okay. All right. Members, I
- 25 would ask for a motion to consider. I think we should

- 1 probably vote on whether -- what the route will be before
- 2 we get into the CEC --
- 3 MEMBER HAMWAY: Absolutely.
- 4 CHMN STAFFORD: -- and the conditions and that
- 5 sort of thing.
- 6 MEMBER HAMWAY: Right.
- 7 MEMBER PALMER: Can I ask one other question?
- 8 CHMN STAFFORD: Yes. By all means, Member
- 9 Palmer.
- 10 MEMBER PALMER: And it was probably answered
- 11 already, but on the north-south portion of the 2B, would
- 12 that right-of-way be on the private portion of that or
- 13 the Forest Service portion of that?
- 14 MR. BRYNER: Yes, Member Palmer. On the
- 15 north-south portion along 2B, the corridor we've
- 16 requested would span both forest and private. The
- 17 intention would be to place that on private, however. We
- 18 did not include that in our Application to the Forest
- 19 Service for the SF299.
- 20 MEMBER PALMER: Thank you.
- 21 CHMN STAFFORD: Any other questions?
- 22 (No response.)
- 23 CHMN STAFFORD: All right. I would ask for a
- 24 motion for, one, to decide whether to decide to go with A
- 25 or B. And then for, two, for B, to go with 1 or 2B, and

- 1 then C for 1 or 2C.
- 2 MEMBER LITTLE: Mr. Chairman, I move that in the
- 3 A region we go with 2A.
- 4 MEMBER HAMWAY: I second that.
- 5 CHMN STAFFORD: All in favor say "aye."
- 6 (A chorus of "ayes.")
- 7 CHMN STAFFORD: Opposed?
- 8 (No response.)
- 9 CHMN STAFFORD: Hearing none, 2A is selected.
- 10 Can I have a motion for segment B?

- 23 actually, we should -- should we make a note that he

- 3 in parenthesis next -- after his description and title.

- 7 also note that --
- 8 MEMBER HAMWAY: We had a limited appearance.

- 13 CHMN STAFFORD: Individual -- limited appearance

- 15 end of the order.

- 17 amended?

- 8 CHMN STAFFORD: Opposed?
- 9 (No response.)
- 10 Hearing none, motion passes. Moving on to the
- 11 project description.
- 12 MEMBER LITTLE: Do we want to put the actual
- 13 length?
- 14 MEMBER HAMWAY: Yeah, I was going to ask. Did
- 15 we exceed the 20 miles by adding 2A and 2B?
- 16 CHMN STAFFORD: I'll defer that to Ms. Grabel,
- 17 who will defer it to Mr. Bryner.
- 18 MR. BRYNER: Sorry. Yes, Mr. Chairman.
- 19 We've not exceeded the 20 miles in length. That
- 20 accounted the 17 miles was on the low end, the 20 miles
- 21 was on the high end. I can add up the miles here. We
- 22 have that in our application. I can get that if we want
- 23 to put the actual.
- 24 CHMN STAFFORD: I think if the range stated in
- 25 the order is accurate, that's good enough. We don't need

- 1 to narrow it down. I don't think.
- Members? Do you agree with that?
- 3 MEMBER LITTLE: That's fine.
- 4 MEMBER HAMWAY: I don't think it matters.
- 5 CHMN STAFFORD: Okay.
- 6 MEMBER HAMWAY: No one ever reads it anyway.
- 7 Did I say that out loud? Don't put that in there.
- 8 THE COURT REPORTER: Sorry.
- 9 CHMN STAFFORD: Members, let me know when you're
- 10 ready to scroll down unless you want to read it out loud.
- 11 MEMBER HAMWAY: No.
- 12 MEMBER LITTLE: Do we change the description to
- 13 reflect what we --
- 14 MEMBER PALMER: What we just voted on?
- 15 MEMBER HAMWAY: Yeah, we need to do that.
- 16 CHMN STAFFORD: Well, the alternates are
- 17 described later on. This is just the -- we'll probably
- 18 want to change the order, findings of facts and orders
- 19 later on, but I think this is just stating --
- 20 MEMBER LITTLE: Oh, okay. Oh, I see. Thank
- 21 you.
- 22 MEMBER PALMER: Okay.
- 23 CHMN STAFFORD: -- what the Applicant stated
- 24 in --
- 25 MEMBER HAMWAY: Okay.

- 1 MEMBER LITTLE: Okay. Thank you.
- 2 MEMBER PALMER: Is there more below that that we
- 3 haven't seen?
- 4 CHMN STAFFORD: Have the members completed their
- 5 review of the -- reviewed the project description for the

- 10 sections. We'll do the preferred route and the
- 11 introduction first and then move to the alternative
- 12 route.

- 14 project overview preferred route.
- 15 MEMBER HAMWAY: Second.

- 21 CHMN STAFFORD: Yeah, I was thinking about doing
- 22 that in the findings of fact and conclusions of law.
- MS. GRABEL: Okay.
- 24 CHMN STAFFORD: At this point we're just
- 25 describing -- you're not going to have an Exhibit A

- 1 reflecting the changes today, are you?
- 2 MS. GRABEL: We can.
- 3 CHMN STAFFORD: You can?
- 4 MS. GRABEL: P-Dub's (phonetic) working on it
- 5 right now.
- 6 Another alternative is to have two maps. We'll
- 7 have an Exhibit A and Exhibit B.
- 8 CHMN STAFFORD: Yeah. I'm inclined to keep this
- 9 sentence, The map of the project, including preferred
- 10 alternative routes as attached as Exhibit A.
- 11 That way when the Commission looks at it, they
- 12 can see they'll have a map of what we're talking about.
- 13 MS. GRABEL: Uh-huh.
- 14 CHMN STAFFORD: Yeah, I like the idea of an
- 15 Exhibit B with the final route.
- MS. GRABEL: Okay.
- 17 CHMN STAFFORD: Members, how do you feel about
- 18 that?
- 19 MEMBER PALMER: Yeah, I think that works.
- 20 MEMBER LITTLE: Works for me, yep.
- 21 MEMBER PALMER: You can add to that.

- 12 I'm going to let Mr. Bryner respond to that
- 13 question.
- 14 CHMN STAFFORD: Thank you.
- 15 MR. BRYNER: Yes, Mr. Chairman. Those are kind
- 16 of two separate issues.
- 17 So this one addresses electrocution of birds
- 18 through -- we minimize that through the design of the
- 19 line and then the way we operate the line.
- 20 What you're referring to would be the temporary
- 21 impacts associated with construction, and we have those
- 22 environmental protection measures.
- 23 If you'll recall Mr. Lindenlaub's testimony that
- 24 we have built and listed into the biological evaluation
- 25 included in the application that includes things like

- 1 preconstruction surveys for nesting birds and things like
- 2 that or constructing outside of those nesting seasons.
- 3 And so we intend to comply with all of those
- 4 environmental protection measures that are listed in the
- 5 application, and I feel that would be adequate to comply
- 6 with what your -- what your concerns is.
- 7 MR. ACKEN: Mr. Chairman, can I --
- 8 CHMN STAFFORD: I'm just trying to consider
- 9 where it's going to be reflected in the conditions.
- 10 Mr. Acken.
- MR. ACKEN: I'm sorry for speaking over you,
- 12 Mr. Chairman. I did want to be heard on this.
- I believe it's addressed in both Condition 1 and
- 14 Condition 5.
- 15 You know, we have -- you know, the Applicant has
- 16 obligations to comply with all applicable federal, state,
- 17 and local laws. That would include laws governing
- 18 migratory birds, which addresses this very issue.
- 19 Condition 5, you know, you've got the Game and
- 20 Fish's guidelines for handling, which also addresses this
- 21 same issue.
- 22 So that's -- that's why, you know, this question
- 23 of how do you handle nesting season arises frequently.
- 24 Conditions 1 and 5 address that.
- 25 CHMN STAFFORD: Thank you. I feel better now.

- 20 CHMN STAFFORD: Member Drago.
- 21 MEMBER DRAGO: I vote aye.
- 22 CHMN STAFFORD: Member Hamway.
- 23 MEMBER HAMWAY: Yes. First of all, I'd like to
- 24 thank Mr. Risner for the amazing presentation of the
- 25 mine. I know that was not jurisdictional, but I do

- 1 appreciate the effort.
- 2 And I appreciate all the residents that came
- 3 out, because it does help us understand the area better.
- 4 And I hope the selections that we've made are helpful to
- 5 the community, and I do believe that this project is
- 6 going to be an amazing economic driver for Santa Cruz
- 7 County.
- 8 And with that I vote aye.
- 9 CHMN STAFFORD: Member Palmer.
- 10 MEMBER PALMER: Thank you, Mr. Chairman.
- I too would like to thank the Applicant, the
- 12 Intervenor, and I want to think the public as well. I
- 13 think it was reflected in some of the routes we adopted
- 14 today their input into this process. And while -- when
- 15 some are for and some are against, everyone never goes
- 16 away completely happy.
- 17 I think given the economic significance to not
- 18 only the area but to our country that this mine plays and
- 19 the necessity of this power line to make that a reality,
- 20 I think we have to look at the greater good, and I think
- 21 the Applicant did a great job of presenting that case to
- 22 us these last three days, and I want to thank them.
- 23 I want to thank Jennifer. There's nothing worse
- 24 than being away from home when you don't feel good. And
- 25 we certainly understand having to stop for a sneeze now

- 1 and then, but thank you for your service here today.
- 2 And with that I vote aye.
- 3 CHMN STAFFORD: Member Little.
- 4 MEMBER LITTLE: I also would like to thank the
- 5 Applicant for the presentation, and in particular the
- 6 willingness to work with the stakeholders in the
- 7 community.
- 8 I also very much appreciate the residents coming
- 9 out and expressing their concerns, their support, their
- 10 requests as has been expressed already here. It's so
- 11 helpful to us.
- 12 I recognize that we are unable to accommodate
- 13 everyone's requests, but I think that both the Applicant
- 14 and we as a Committee have tried to do our best.
- 15 And I also appreciate the thoroughness of the
- 16 Applicant in planning and studying the addition of this
- 17 line to the -- to Arizona and the western grid. I think
- 18 that's important and is often maybe shortchanged a little
- 19 bit.
- 20 The siting process study was very interesting to
- 21 me also. I appreciate that.
- 22 And with that I vote aye.
- 23 CHMN STAFFORD: Member Gentles.
- 24 MEMBER GENTLES: Mr. Chairman, I vote aye.
- 25 CHMN STAFFORD: And I vote age as well.

1	By a vote of 8 to 0, the CEC's approved.
2	You can put today's date on the last page as
3	well.
4	Anything further from the parties?
5	MS. GRABEL: No, Mr. Chairman. Thank you and
6	the Committee very much again for your efforts.
